The Authority confirmed the name of the landlord of the premise and requested the applicant correct the application.

Mr. Gallegos stated he will continue with the same hours of operation of the business and the employees that will be serving alcohol will attend TIPS training. Mr. Gallegos stated identification will be required for alcohol service and understands the orientation of the ID for individuals underage. Employees that serve underage individuals will be

terminated. Mr. Gallegos stated there have been no issues pertaining to alcohol since issuance of the temporary license.

Based on the application and statements of the applicant, the Authority finds the evidence presented does support that the applicant at this time is qualified to conduct the type of business proposed and the license is approved contingent on receipt of an amended premise map to include dimensions, apply with the liquor code, state regulations and Windsor municipal ordinances.
