Vanrang Ratsamy appeared to address the Authority. Mr. Ratsamy completed the TIPS training soon after the violation and stated the employee that received the violation attended TIPS training but is no longer employed at the establishment. Mr. Ratsamy and his wife work in the front of the house and there are kitchen employees as well. There is a 17-year-old that works in the mornings but they cannot touch alcohol at all. The state liquor enforcement did a compliance check and the establishment passed. Individuals that look to be under the age of 50 are required to provide identification for liquor service.


The Authority finds based on the application and information provided that the renewal application will be approved.
