



Washer Rebate Information and Program Rules

High efficiency washer rebate rules:

- Washer must be purchased from Manweiler Appliance, 414 Main Street, Windsor, CO between September 1, 2017 and December 31, 2017.
- Rebate applications must be submitted within 90 days of purchase. All washers purchased prior to December 31, 2017 must be submitted before January 15, 2018.
- Only water customers in good standing (account with a zero balance) may apply. Windsor residents receiving water from Loveland/Fort Collins Water District must provide a letter from the District stating they are in good standing with a non-delinquent account.
- Rebate is limited to one washer per residence.
- Receive up to a \$100 rebate from the Town of Windsor on a new washer; rebates are subject to available funds.
- To be eligible for the rebate, the washer must be purchased from Manweiler Appliance and listed on the latest CEE1.org listing. Please consult the manufacturer information for qualifying models.
- The Town reserves the right to inspect the installation of any appliance for which a rebate is provided. Rebates can be filed by the property owners or renters. Contractors or others working for a property they do not own cannot apply for the rebate. The homeowner is responsible for installation.

How to apply:

- Purchase and install high efficiency washer according to program rules.
- Bring completed form and receipt of purchase to the Town of Windsor, 301 Walnut Street, Windsor, CO 80550. Applications are accepted in person, by mail or email.
- If you file by mail or email (utilities@windsorgov.com) you will need to have the application notarized.
- A copy of your ID will be required. A Colorado driver's license is the preferred form of ID. We will also accept U.S. military card or passport.
