Town Board Liaison:

Myles Baker reported the following:

- Introduced himself and provided a brief background of family and involvement with the Town of Windsor (previously served on PReCAB, Water and Sewer, Front Range Metro Planning Organization, currently also serving on Historical Society, six years on Town Board).
- Capital improvement plan-roughly \$45 million, re-investing large amount of money back in to the community (Diamond Valley, sewer projects, paying roads).
- With growth, impact fees are collected, goal is to put those back into the community.
- No further updates on downtown development, Rocky Mountain Sports Park, urgent care.

D. BOARD DISCUSSION

1. Tree Board and PReCAb Combination

Mr. Lucas reported on the following:

- Held a discussion with Mr. Kawamura and Ms. O'Connor about a proposed idea in order to bring both Boards together jointly and work more collaboratively, possible opportunities for sub committees
- Boards would meet on the same day, Tree Board would be meet beforehand and then liaison from Tree Board would attend PReCAB as a voting member following, can be on a rotation basis each year
- Save on staffing, provide advocacy for input, ideas and thinking, budget, and specific items to go to Town Board/approval
- Two vacancies coming up on PReCAB, one is an internal fill and that person will reapply
 when term is up, the other vacancy will not be reapplied for and will be open for a Tree
 Board member as a guaranteed position from here on out
- An idea to give some thought to, not asking for a decision immediately
- Next PReCAB meeting is on September 11, 2018-Welcome to attend

Ms. O'Connor-Next meeting is September 25th at Highland Meadows for audit, so further discussion can happen at October meeting.

2. Landscape Standards

Mr. Lucas reported the following:

- Things moved very quickly the past 30 days
- Booklet adopted in 2006 went to Town Board in 20011and voted down
- Board and Planning Department have streamlined the code and currently doing a code review on landscape standards and a variety of other topics, all will be combined into one, will be run through the Planning Department to get codified, once approved by Town Board then adopted at the end. The booklet will go away as it has been known and will then be a part of the Town Board Code
- Staff has been meeting with Planning Department taking 2011 recommendations and beyond that needs to be in the new code with minor modifications
- Will be going to Town Board in a work session on September 10, 2018, in order to review, ask questions, make changes if needed, and codify
- A second agenda item that will be addressed at Town Board-Article 7 Growth of right away (in, on, over or upon), law currently reads that it is the Town's responsibility, number of areas where this is happening, can be extremely costly
- Will take to Town Board to change language-If rooted in one's property, it will be the homeowner(s) responsibility to take care of the maintenance and the Town's responsibility to enforce the maintenance or charge the homeowner
- Mr. Kawamura and staff will not be able to dedicate necessary time to assess all growth around town, will need to hire on others
- Will need to publicize and educate the public about changes to law

- Recommendations for licensed arborist
- Build into budget for homeowner removal allocations/stipend/EAB funding

D. BOARD DISCUSSION

1. Park/Tree Audit

History of Windsor Highlands Park:

- The park was planted in 2005
- It is considered a "neighborhood park"
- The park is used for many things, such as walking, soccer, lacrosse, flag football and has a playground

Assessment of Windsor Highlands Park:

• Mr. Kawamura provided the Tree Board with an auditing form that the Board used to provide feedback and comments. Note-The rating scale was 1-5; with 1 being "needs improvement" and 5 being "excellent"

- Species: 5/5
 - o The Board noted at least 22 different species planted in the park
 - o There are zero ash planted in the park!
- Size: 4/5
 - The park is large with one playground and plenty of space for kids, dogs and people to recreate. Parking is readily available
 - A walking path is available around the perimeter of the park
- Condition of Trees: 4/5
 - Trees are on the smaller side and were planted all at once; no additional plantings have been done in the park-only replacements
 - o The trees range in size from 8-14" DBH
 - o Some trees were planted too deeply
 - A few trees had mechanical injury from mowers/string trimmers; broken branches from kids
 - The trees did not have mulch rings or sprayed tree rings at the base, so grass maintenance must be done, which can damage the trees (see bullet above)
 - -The Board recommends adding mulch rings or spraying the tree rings with glyphosate (Roundup) to keep mowing equipment away from the trunks
- Site: 5/5
 - The park provided a great place for many activities the night the Board visited-there was soccer, flag football, kids on the playground, people walking their dogs, kids playing on the grass, etc.
 - o The park itself was very well maintained
 - There are no bathrooms because it is considered a neighborhood park (most who utilize the park live in close proximity)
 - o There is a large parking lot with ample parking available
- Age Class: 2/5
 - The trees in the park were mostly planted at the same time (in 2005)
 - O A few younger trees have been added, but only as replacement trees
 - There are plans to plant additional trees (it's allocated in the budget)to help diversify the age class of the park's trees.
- Diversity: 4/5
 - Mr. Kawamura estimates that approximately 20+ species of trees are represented in the park
- Available planting Space: 5/5
 - o There is space available on the outside perimeter of the park
 - Trees can also be planted on the east side, south of the playground (it's a large turf area)
- Uniqueness: 3/5
 - The park itself isn't overly unique, but the trees in the park are unique-like ginko row and the chinkapins that are located near the west entrance
 - While the park may not have the history of other parks in Windsor, it is heavily used and appreciated by the residents in Highland Meadows
- Nobility: 3/5
 - The one major eyesore was the west side entrance where there was unmowed grass that turned in to a large weedy patch-it had noxious weeds (Canada thistle) and several annuals that had gone to seed (prickly lettuce)
 - -The Board's recommendation was to either mow this area as turf or simply mulch it to reduce weed growth

- The ornamental grasses adjacent to this area were also suffering (drought? Lack of maintenance?) and could use a refresher
- Accessibility: 3/5
 - The park doesn't allow for vehicle traffic inside the boundaries, but there is a large parking lot on the west side
 - o There are paved paths throughout the park and around the outside perimeter
 - The playground has synthetic turf that can improve accessibility-but this surface is high maintenance and is also very hot in the summer, so the playground isn't utilized as much because of the heat from the synthetic turf surface
- Overall Rating: 4/5
 - The Board thoroughly enjoyed their visit and audit of Windsor Highlands Park
 - The only thing to improve upon is to diversify the age of trees, which will come as time goes on-some of the trees have been replaced, but there will be additional tree planting efforts in the future
 - The Board was excited about the number of unique species that were planted in the park and supportive of Mr. Kawamura's efforts to push the boundaries and plant new material-this should continue
 - The Board would like to see the following planted: Caddo Sugar Maple, "Decaf' Kentucky coffeetree, additional ginkoes, new oak cultivars, more evergreeens?

- Planted fall annuals
