

## MOTORIZED UTILITY VEHICLE

### WMC 8-5-10 through 8-5-60

A *motorized utility vehicle (MUV)* is defined as either:

(1) A four- or six-wheeled chassis and cargo bed powered by a 4-cycle gasoline or diesel motor; a drivetrain consisting of a continuously variable transmission; seating for a driver and one (1) passenger side-by-side; designed to travel at speeds not to exceed twenty (20) miles per hour; maintains a low center of gravity riding upon high-flotation tires; may be equipped with a trailer, cab enclosure, headlights, implements and similar attachments; and primarily designed for transporting loads, freight and maintenance equipment;

or

(2) Any motorized equipment used for cutting grass, cutting weeds, maintaining landscaping and related purposes.

- MUVs shall be used only for the property maintenance-related functions of the Town, local school district, local special districts, local metropolitan districts and other private property owners with significant commercial property maintenance duties. MUVs may be operated on any trail owned or operated by the Town or any duly-constituted trail authority for the purpose of maintaining property owned or operated by the Town or any such trail authority. WMC 8-5-20
- Operator must be at least 16 years of age with a valid driver license.
- All MUVs operated upon any road within the Town shall be equipped with a slow-moving vehicle emblem and shall bear a visible insignia, label or decal indicating the owner's name.



## EPAMDs

### WMC 8-1-80

An *Electric Personal Assisted Mobility Device (EPAMD)* is defined as a self-balancing, two-nontandem-wheeled device, designed to transport only one (1) person, with an electric propulsion system that limits the maximum speed of the device to twelve and one-half (12.5) miles per hour or less.

- Must be 16 years of age or older to operate an EPAMD.
- EPAMDs shall be considered bicycles and shall be subject to the Model Traffic code provisions and regulations concerning bicycles.
- May not be operated on State Highways except to cross the road.
- May not be operated on the Poudre River Trail within the Town limits.



## ALL TERRAIN VEHICLES (ATV)

(Off highway vehicles)

CRS 33-14.5-108

- ATVs may not be operated on the public streets or roads except for limited cases as outlined in this statute. ATVs are not allowed to be utilized on roadways for general transportation or recreational purposes.

## GOLF CARTS

### WMC 8-6-10 through 8-6-50

A *golf car* is a self-propelled vehicle not designed primarily for operation on roadways and that has:

- (1) A design speed of less than twenty (20) miles per hour;
- (2) At least three (3) wheels in contact with the ground;
- (3) An empty weight of not more than 1,300 pounds; and
- (4) A carrying capacity of not more than four (4) persons.

- Permission to operate a golf car in a neighborhood or subdivision may only be authorized by the Town Board. The only neighborhoods currently with such permission are the north & south subdivisions of Water Valley.
- The operator must be at least 16 years of age with a valid driver license.
- No golf car shall be operated upon any sidewalk, pedestrian trail or recreational facility within the Town.
- Golf cars may not be operated upon or across any portion of Highways 392 or 257
- Operators must obey all traffic & parking regulations applicable to motor vehicles.
- Golf cars operated between sunset & sunrise or during times of limited visibility must be equipped & illuminated with head lamps, tail lamps, stop lamps and turn signals
- Golf cars shall be operated as close to the right side of the road as practicable.



## TOY VEHICLES & GO CARTS



“Toy vehicle” means any vehicle that has wheels and is not designed for use on public highways. CRS 42-1-102 (103.5) (a)

Toy vehicles include, but are not limited to gas or electric powered vehicles commonly known as **mini bikes, “pocket” bikes, kamikaze boards, go-peds, and stand up scooters.**

Toy vehicles are **not permitted on any sidewalk or roadway** and are for private property use only!

## LOW POWER SCOOTERS

Defined CRS 42-1-102 (48.5)



Requirements & regulations:

- Must not exceed a speed of 40 mph and operator must ride on the right portion of the roadway. Not to exceed 50 cc combustion engine or 4,476 watt electric engine. CRS 42-4-109; 42-1-102 (48.5)
- Valid driver’s or minor’s license required—Instruction permits or temporary licenses not included. CRS 42-2-103 (2)(a)
- Must be registered, have a registration sticker in plain view and a visible ID # stamped on its frame. CRS 42-3-311
- Insurance required. CRS 42-4-1409
- Operator/passengers are required to use eye protection and any operator/passenger under age 18 shall use a helmet. CRS 42-4-232; 42-4-109
- Operator/passengers must adhere to all traffic laws and equipment requirements.
- Maximum occupancy is dependent upon manufacturer design (see owner’s manual). CRS 42-4-109
